## «Admission Policy of the Graduate School of Science»

Science is an academic discipline, wherein the principles and laws of nature are elucidated and truths are explored, shaped by an insatiable intellectual curiosity about humanity's fundamental questions regarding nature. In addition, science is the foundation of various fields, such as science and technology, humanities, and social sciences, supporting modern society, and is closely related to human life.

The Tohoku University Graduate School of Science works to train world-leading researchers and professionals who are active in various fields of science with humanity and ethics through advanced specialized education based on cutting-edge research.

The Graduate School of Science seeks the following characteristics in students wishing to enroll in the university:

- Those who have the basic academic abilities necessary for scientific research and a strong desire to study at this university
- Those who want to inherit humanity's intellectual heritage, and search for natural truths with freedom of thought and originality to contribute to the advancement of the next generation of natural sciences and technologies.
- Those who have the humanity, ethics, and willpower to become researchers and highly skilled professionals contributing to the development of human culture and society based on scientific thinking.

When accepting students, we conduct a general selection, a special selection for international students, self-recommendation entrance examinations (Master's Program), and a special selection for working adults (Doctoral Program) for each of the six departments with emphasis on whether or not the applicants have the abilities and qualities necessary to conduct research in line with the educational philosophy and goals of the Graduate School of Science.

### (Master's Program)

In the general selection, there are a written examination to evaluate basic academic abilities necessary for research in specialized fields, and an oral examination based on the applicant's research plans, research abilities and motivation for research; particular emphasis is placed on basic academic abilities and research motivation.

In the self-recommendation entrance examination, an oral examination is performed to evaluate the applicant's ability to obtain basic academic knowledge, not only in specialized fields but also in different fields, and to achieve learning and research goals from complex and practical perspectives. Applicants are selected with particular emphasis on basic academic abilities and motivation for learning and research.

In the special selection for international students, oral examinations are conducted to evaluate basic academic abilities necessary for research in specialized fields, logical thinking skills, English skills, research plans and motivation for research, etc., and applicants are selected with particular emphasis on basic academic abilities and research motivation.

Before enrollment, students must have the basic academic skills necessary to acquire advanced knowledge and conduct research in their specialized fields.

## 2. Eligibility

Applicants eligible for the Special Selection are international students and Japanese nationals who have received formal education at a university outside Japan (Japanese returnee).

[NOTE]

- ① "International students" refers to individuals who do not hold Japanese nationality and have not been granted permanent residency in Japan.
- ② "Japanese returnees" refers to individuals who either hold Japanese nationality or have been granted permanent residency in Japan, and who have received formal education at a university outside Japan.
- ③ Those who apply for the Special Selection must complete certain preparations before submitting their application. For details, please refer to "**4. Important Notes on Application for Special Admission for International Students and Others**" on page 4.

Applicants for the program must fulfill one of the following conditions.

#### October 2026 Admission

- (1) A person who graduated (or will have graduated) from a university by September 30, 2026;
- (2) A person who obtained (or will have obtained) a bachelor's degree from NIAD (National Institution for Academic Degrees and Quality Enhancement of Higher Education) by September 30, 2026;
- (3) A person who completed (or will have completed) a 16-year curriculum of schooling abroad by September 30, 2026;
- (4) A person who completed (or will have completed) a 16-year curriculum of schooling of a foreign country by taking course subjects in Japan through a correspondence education course provided by a school of such foreign country by September 30, 2026;
- (5) A person who completed (or will have completed) a university course of a foreign country (limited to a course upon completion of which the person who completed it is deemed to have completed a 16-year curriculum of schooling of such foreign country) provided by an educational institution in Japan that is recognized, under the schooling system of such foreign country, as a provider of university courses of such foreign country, and that is separately designated by the Minister of Education, Culture, Sports, Science and Technology by September 30, 2026;
- (6) A person to whom a degree equivalent to a bachelor's degree was (or is expected to be) conferred by September 30, 2026 after completing a course whose duration of study was at least three years at a foreign university or other foreign school (limited to foreign universities/schools whose comprehensive conditions such as their education and research activities are assessed by a party certified by the government of the foreign country or a relevant organization, or equivalent foreign universities/schools separately designated by the Minister of Education, Culture, Sports, Science and Technology) (including those who completed (or will have completed) such course by taking course subjects in Japan through correspondence education provided by a school of the foreign country, or those who completed (or will have completed) such course at an educational institution that is recognized under the schooling system of the foreign country and is designated as prescribed in the preceding item);
- (7) A person who completed (or will have completed), after the day or by September 30, 2026 designated by the Minister of Education, Culture, Sports, Science and Technology, a specialized course at a specialized training college (limited to such course whose duration of study was at least four years, and which satisfied other standards set by the Minister) separately designated by the Minister;
- (8) A person designated by the Minister of Education, Culture, Sports, Science and Technology; (Ordinance of the Ministry of Education, Science and Culture No.5 of 1953)
- (9) A person who was enrolled in a university for at least three years, who completed (or will have completed) a 15-year curriculum of schooling abroad, who completed (or will have completed) a 15-year curriculum of schooling of a foreign country by taking course subjects in Japan through correspondence education provided by a school of such foreign country, or who completed (or will have completed) a university course of a foreign country (limited to such course upon completion of which the person who completed (or will have completed) it is deemed to have completed a 15-year curriculum of schooling of such foreign country) provided by an educational institution in Japan that is recognized, under the schooling system of such

foreign country, as a provider of university courses of such foreign country, and that is separately designated by the Minister of Education, Culture, Sports, Science and Technology by September 30, 2026; and furthermore who is found, by the Tohoku University Graduate Schools, to have achieved excellent results in acquiring the prescribed credits;

- (10) A person who enrolled in a graduate school of another university pursuant to the provision of Article 102, Paragraph 2 of the Act and who is regarded by the Tohoku University Graduate Schools as having academic abilities deserving of receiving the education thereof; or
- (11) A person who is deemed, through an individual university entrance qualification assessment, to have academic abilities at least equivalent to those of university graduates by the Tohoku University Graduate Schools, and also who has reached (or will be reached) the age of 22 by September 30, 2026.

#### April 2027 Admission

- (1) A person who graduated (or will have graduated) from a university\* by March 31, 2027;
- (2) A person who obtained (or will have obtained) a bachelor's degree from NIAD (National Institution for Academic Degrees and Quality Enhancement of Higher Education) by March 31, 2027;
- (3) A person who completed (or will have completed) a 16-year curriculum of schooling abroad by March 31, 2027;
- (4) A person who completed (or will have completed) a 16-year curriculum of schooling of a foreign country by taking course subjects in Japan through a correspondence education course provided by a school of such foreign country by March 31, 2027;
- (5) A person who completed (or will have completed) a university course of a foreign country (limited to a course upon completion of which the person who completed it is deemed to have completed a 16-year curriculum of schooling of such foreign country) provided by an educational institution in Japan that is recognized, under the schooling system of such foreign country, as a provider of university courses of such foreign country, and that is separately designated by the Minister of Education, Culture, Sports, Science and Technology by March 31, 2027;
- (6) A person to whom a degree equivalent to a bachelor's degree was (or is expected to be) conferred by March 31, 2027 after completing a course whose duration of study was at least three years at a foreign university or other foreign school (limited to foreign universities/schools whose comprehensive conditions such as their education and research activities are assessed by a party certified by the government of the foreign country or a relevant organization, or equivalent foreign universities/schools separately designated by the Minister of Education, Culture, Sports, Science and Technology) (including those who completed (or will have completed) such course by taking course subjects in Japan through correspondence education provided by a school of the foreign country, or those who completed (or will have completed) such course at an educational institution that is recognized under the schooling system of the foreign country and is designated as prescribed in the preceding item);
- (7) A person who completed (or will have completed), after the day or by March 31, 2027 designated by the Minister of Education, Culture, Sports, Science and Technology, a specialized course at a specialized training

college (limited to such course whose duration of study was at least four years, and which satisfied other standards set by the Minister) separately designated by the Minister;

- (8) A person designated by the Minister of Education, Culture, Sports, Science and Technology; (Ordinance of the Ministry of Education, Science and Culture No.5 of 1953)
- (9) A person who was enrolled in a university for at least three years, who completed (or will have completed) a 15-year curriculum of schooling abroad, who completed (or will have completed) a 15-year curriculum of schooling of a foreign country by taking course subjects in Japan through correspondence education provided by a school of such foreign country, or who completed (or will have completed) a university course of a foreign country (limited to such course upon completion of which the person who completed (or will have completed) it is deemed to have completed a 15-year curriculum of schooling of such foreign country) provided by an educational institution in Japan that is recognized, under the schooling system of such foreign country, as a provider of university courses of such foreign country, and that is separately designated by the Minister of Education, Culture, Sports, Science and Technology by March 31, 2027; and furthermore who is found, by the Tohoku University Graduate Schools, to have achieved excellent results in acquiring the prescribed credits;
- (10) A person who enrolled in a graduate school of another university pursuant to the provision of Article 102, Paragraph 2 of the Act and who is regarded by the Tohoku University Graduate Schools as having academic abilities deserving of receiving the education thereof; or
- (11) A person who is deemed, through an individual university entrance qualification assessment, to have academic abilities at least equivalent to those of university graduates by the Tohoku University Graduate Schools, and also who has reached (or will be reached) the age of 22 by March 31, 2027.

[NOTE]

- ① Those who apply under the eligibility requirement of (6) should contact the Graduate Academic Affairs Section by Wednesday, June 10, 2026. Besides, those who apply for the Special Selection for International Students should see **“Section 4: Important note for those who apply for the Special Selection for International Students”**.
- ② Those who apply under the eligibility requirements of (9), (10), or (11) should take a preliminary screening before making a formal application. (See **“Section 3: Preliminary Screening”** and follow the instructions)

### 3. Preliminary Screening

Those who apply under the eligibility requirements of (9), (10), or (11) must undergo the following preliminary screening procedures.

[NOTE]

The Preliminary Screening for the Special Selection for International Students is informed to applicable persons respectively. Therefore, the following information for (1), (2), and (3) is simply the English translation of the original guide in Japanese for your reference.

(1) Preliminary Screening Procedure

- ① Application Deadline: Wednesday, June 17, 2026
- ② Those who wish to apply for the preliminary screening are required to fill out the necessary information in the Google Form in advance.



- ③ After completing the Google Form, please download the Preliminary Screening Application Form from the Graduate School of Science website, fill it out, print it, and submit it by post along with the required documents.

Be sure to send the documents by express registered mail. On the front of the envelope, clearly write in red: "Application Documents for Preliminary Screening for Master's Program (Fall Semester) Enclosed."

Only applications that arrive by Wednesday, June 17, 2026, will be accepted.

- ④ Applications that lack necessary documents, are incomplete or are otherwise inadequate will not be acceptable.
- (1) The preliminary screening results will be announced via email by Thursday, June 25, 2026.
  - (2) Those who are granted eligibility through the preliminary screening must complete the application procedures during the designated application period. Also, please print out the screening result and bring it with you on the examination day. You may be asked to present it by the examination supervisor or staff, so be prepared to show it upon request.

#### 4. Important notes for those who apply for the Special Selection for International Students

Those who apply for this program must find a prospective supervisor by themselves and obtain consent from him/her about the application before applying. Visit the faculty on the department website and contact them directly by email to obtain their consent to study under him/her. After obtaining consent, prepare for the application.

Note that your prospective supervisor needs to inform their department chair of your application by the dates below so that you must obtain the consent by then:

- (1) October 2026 Admission: Friday, June 26, 2026

(2) April 2027 Admission: Wednesday, September 30, 2026

The application period and other relevant information for April 2027 Admission should be separately informed.

## 5. Applicants who need Special Assistance

Applicants who need special assistance or consideration either in taking the examination or after enrollment due to their particular conditions should consult the Graduate Academic Affairs Section (see the last page) by Thursday, June 25, 2026. Please notify them at once so that they have sufficient time to take the necessary measures. Be assured that such a request will in no way influence the outcome of the selection process.

## 6. Application Procedure

(Note that application for the Special Selection for International Students can be accepted only after obtaining consent from your prospective supervisor, as instructed in Section 4.)

Please make sure to click the "Complete my application" button within the designated period to complete your application. Your application will not be considered complete unless you click this button.

Also, if the application period ends before you click the button, your application will not be accepted. We recommend completing the process well in advance to avoid any issues.

[April ~~2026~~-2027Admission]

The Graduate Academic Affairs Section will notify applicants about the application period and other relevant information.

③ Applications that lack necessary documents, are incomplete or are otherwise inadequate will not be acceptable.

④ Physics major applicants are requested to select their preferred research or interview group according to the on-screen instructions when entering information into the online application system.

⑤ Geophysics major applicants should specify the first and the second interest from the research field from (A), (B), and (C) below in the online application system.

Applicants are strongly encouraged to consult with faculty members in their intended field or area of study prior to submitting their application.

- (A): Seismology and Volcanology, Physics of Subduction Zones

- (B): Meteorology and Atmospheric Dynamics, Physical Oceanography, Atmospheric Trace Gas, Physical Climatology, Satellite Oceanology

- ⑥ Earth Science major applicants should specify one of the research groups from (A), (B), and (C) below in the online application system.

  - (B): Environmental Geography, Geoenvironmental Dynamics, and Natural Disaster Science

- ⑦ Making false or misleading statements on the application may result in the cancellation of admission status.
- ⑧ After submission, declining an application and amendment to written information on the application documents cannot be allowed. The relevant application documents are not returnable and the entrance examination fee is not refundable.
- ⑨ After the application deadline, if your application is accepted, your examination admission ticket will be made available through the online application system. You will be notified via the email address you registered when your examination admission ticket becomes available. Please note that all important information related to the examination will also be sent to your registered email address. Therefore, be sure to enter an accurate and reliable email address at the time of application and check your email regularly after submitting your application.
- ⑩ Please download your examination admission ticket from the online application system, print it out, and be sure to bring with you on the day of the examination.

## 7. Examination and Selection Method

The selection of applicants is determined based on the evaluation of the submitted documents and their performance in proficiency examinations of specialized subjects, foreign language (and Japanese language, if necessary), and an oral examination.

## 8. Examination and Selection Schedule

### (1) Schedule and Selection Method

The examination is conducted during the following periods:

(2) Admission Fee and Tuition Fee

[April 2027 Admission]

- ① Admission Fee: JPY 282,000 (as of 2026)
- ② Tuition Fee: JPY 900,000 per year (as of 2026)  
(Tuition fee should be paid each semester)
- ③ Scholarship for International Students

Scholarships equivalent to either the full amount of tuition or one-half of the tuition shall be awarded to approximately the top one-third of students selected based on entrance examination results, academic performance, and other relevant factors.

[NOTE] The existing tuition exemption program based on financial need will be discontinued at the end of the 2026 academic year. A new scholarship program for international students will be established beginning in the 2027 academic year.

[NOTE] The above amount is subject to change. If there is a revision to the payment amount, the revised amount will apply from the time the change takes effect.

## 11. Miscellaneous Information

### Handling of Personal Information

- ① Personal information held by Tohoku University is handled in strict compliance with the "Act on the Protection of Personal Information (Act No. 57 of 2003)" and other laws and regulations, and in accordance with the "Regulations of Protection of Personal Information at National University Corporation Tohoku University" and other relevant regulations of Tohoku University, to ensure the protection of personal information.
- ② Personal information such as test scores used for admission selection will be used for the following purposes: selection of applicants, admission procedures, pre-entrance education, follow-up surveys, etc., student support after admission (scholarships, tuition exemption, health care, etc.), educational purposes such as academic guidance, tuition collection, and surveys and research (improvement of entrance examinations, surveys and analysis of application trends, etc., for enrolled students, this includes analysis together with personal information after enrollment).
- ③ Work related to entrance examinations and educational affairs may be performed by contractors entrusted by the University (hereinafter referred to as "contractors"). In the event that all or part of the personal information is provided to the contractor, necessary measures will be taken to ensure that the information is handled appropriately in accordance with the "Regulations of Protection of Personal Information at National University Corporation Tohoku University" and other relevant regulations of Tohoku University.
